

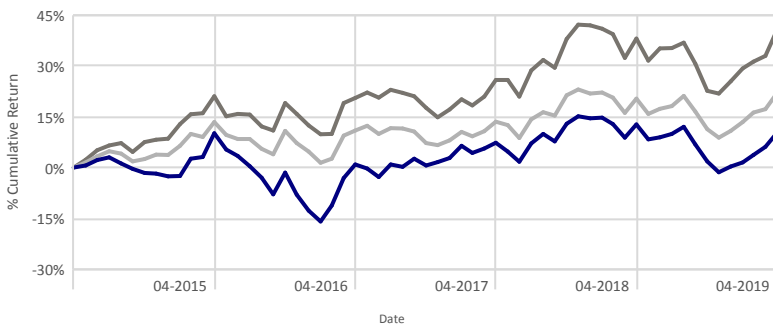
INVESTMENT OBJECTIVE

In selecting securities for this portfolio, where possible, the manager shall seek to sustain high long-term capital growth. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes and other similar schemes which are consistent with the portfolio's primary objective. The portfolio's equity exposure will always exceed 75% with the balance, if any invested in assets in liquid form.

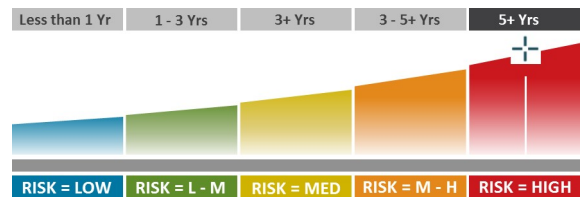

High Risk
